### **JOIN MAINE'S IAP RAPID RESPONSE TEAM!**

Participants who complete **Part I** of this course qualify to become a certified member of Maine's IAP Manual Control Team and also meet the requirement for participating in IAP control programs that receive State funding. Completion of **Part 2** is required for those who will be participating in State funded IAP control projects involving DASH. At the conclusion of the training you may elect to complete a questionnaire and become registered on the Team roster. The roster is made available to lake associations, municipal officials, state agencies, and others interested in hiring divers and those trained in surface support to do invasives-related work.
